THIS IS A RELEASE OF LIABILITY --READ CAREFULLY BEFORE SIGNING

In return for receiving permission from the Town of Green Mountain Falls allowing me to participate as a volunteer in a trails maintenance day, I agree to assume all risks for loss or injury that might arise out of my participation and I agree to waive any and all claims against the parties described below.

I hereby release, and agree to indemnify and hold harmless the Town of Green Mountain Falls, project crew leaders, project participants, sponsors, and their respective agents, representatives, employees, successors, assigns, and insurers, hereinafter referred to collectively as "the Released Parties", from any and all liability, claims, demands or actions or causes of action whatsoever, arising out of damage, loss or injury to my person or property, whether anticipated or unanticipated, while participating in any of the activities contemplated by this agreement, whether such damage, loss, or injury results from negligence of the Released Parties, their respective agents, officers, employees, successors, assigns and insurers or from some other cause. This release and agreement shall be binding on me, my heirs, successors, assigns, administrators, and executors.

I expressly acknowledge, represent and agree that expressly identifying and explicitly naming the respective agents, representatives, officers, employees, successors, assigns, and insurers of the released parties, all of whom I intend to be released by this document, is a practical impossibility for the parties.

I expressly acknowledge that, for good and valuable consideration, the terms "respective agents, representatives, officers, employees, successors, assigns, and insurers" however used in this Waiver and Release Agreement, are expressly and explicitly intended to include all and each and every individual, person, firm, entity, and corporation who are now, or at any time may have been included in the specifically listed categories.

I realize that working on this project may involve risks and hazards, which may include, but are not limited to (1) the use of tools and other construction related equipment, (2) working around other participants who may not be accustomed to this type of labor or the tools and equipment associated with it, (3) working in mountainous, back country, or other rural terrain that maybe uneven, rocky, and otherwise hazardous. I am aware of these and other risks and hazards inherent in participating in this project and hereby assume sole responsibility for all such risks and hazards.
